

## USSVI Charleston Base Meeting Minutes

The attendance for the February 2014 meeting was 65.

**Opening Ceremonies:** The meeting was called to order by Base Commander Ed Stank. A quorum was present and the meeting started at 1904. Following the Pledge of Allegiance, the Invocation and Tolling of the Boats lost in February was given by Base Chaplain Nick Nichols. The USSVI Creed was read by Base Vice-Commander Jerry Stout. Ed welcomed the members and guests to the meeting.

**Secretary:** Base Secretary Rick Wise reported that the January meeting minutes had published in the newsletter and on the base website. Nick Nichols made a motion to approve the January meeting minutes as published. The motion was seconded and carried on a voice vote.

**Treasurer:** Base Treasurer Steve Morawiec gave a report on the Charleston Base finances.

**Vice Commander:** Base Vice Commander Jerry Stout reminded the members that nominations could be made for the Secretary and Vice Commander positions that will be voted on at the May meeting. Ken Hutichison volunteered to be the Election Coordinator. As Special Events Coordinator, Jerry reminded the base of the Hunley-Housatonic Memorial Service at Sunrise Presbyterian Church on Sullivans Island on Monday, February 17. **WEBMASTER REPORT:** The website is being updated frequently. Keep the inputs coming and I'll get them posted. There is a section on the website to announce boat reunions.

**Membership:** Membership Chairman Don Mook reported we now have 316 members. Eighteen 2013 members have been dropped for failing to pay 2014 dues.

**Storekeeper:** Base Storekeeper Ken Hutchison reported he still has calendars. As Election Coordinator he reported he has two nominations for Base Vice Commander – Don Mook and Jerry Stout and that Rick Wise is running unopposed for Base Secretary.

**Newsletter:** Steve Moraweic reported that the electronic newsletter has been sent out. The printed newsletter will go out soon.

**Veterans Affairs/ DAV:** Ken Curtis started by asking for a show of hand of members who have Concealed Carry Permits. He pointed out that the bill recently signed by the Governor makes some changes and those members with permits should check out what has changed.

Ken talked about the VA death benefits and recommended members have a VA Form 21-534 Application for Dependency and Indemnity Compensation, Death Pension and Accrued Benefits by a Surviving Spouse or Child (Including Death Compensation if Applicable) filled out for their dependents.

**FRA:** Larry Cox told the members the red tickets he had given out were for either a one year membership to the FRA or, if you are already a member, one steak dinner.

**Scholarship:** Chairman Julian Villegas reminded the base that he had Charleston Base Challenge Coins for sale at \$12 each to support the Scholarship Fund. The new applications are available on-line. The deadline for applications is April 15<sup>th</sup>. The Scholarship Committee has an empty seat to be filled.

**Submarine Veterans of World War II:** Mike Emerson reminded the base that the next meeting is at Ryan's in Summerville at 1130 on Thursday February 20.

He also talked about the status of Lee Allison in Florida. Lee really misses us and will appreciate any calls or cards. His address and phone number is on the base website sailing list.

**Clamagore Restoration and Maintenance Association:** CRAMA Secretary Rick Wise reported has two paths we are pursuing: 1) to convince Patriots Point to turn over the Clamagore to CRAMA and 2) to raise the funds to restore the Clamagore when we get it.

**Nuclear Historian:** Rick Carlson read the following portion of letter to the editor from Suzanne Flowers of North Charleston. Her father was a WWII veteran who was in charge of one of the USS Clamagore's overhauls at Charleston Naval Shipyard.

"The modesty of my father's generation stands in stark contrast to the tacky bragging of today."

**District Commander:** Paul Viering reminded the base the SE Regional Conference will be held April 7 – 11 at Cary, NC. The Tarheel Base is running the event. There is a link on the website to get your reservation in.

May 16 and 17 the North Carolina SubVets will be holding the WWII Memorial Ceremony on Moonshine Mountain, Burnsville, NC.

National Elections are coming up. Look at the information on the issues and candidate before voting. Don't just act like sheep.

He also reminded the base that this July would be the 17<sup>th</sup> anniversary of the founding of Charleston Base.

**Chief of the Boat:** Rick Sparger pointed out the donation jar on the Base Storekeepers table. These donations are to share the cost with the Palmetto Base for the food and beverages at the reception following Ken Fuhr's funeral.

We still have no one volunteering to serve on the Recreation Committee. If no one steps up the Oyster Roast will be cancelled.

The Hunley-USS Housatonic Memorial Service will be held at the Sunrise Presbyterian Church, Sullivans Island, SC at 7 pm. The uniform is the Charleston Tuxedo (Navy Blazer, khaki pants, light blue shirt, and submarine or dark tie).

The USS Trout Reunion will be held in Mt. Pleasant, SC on 24-27 March.

**Base Commander:** Ed Stank thanked the members that showed up at the meeting despite the effects of the ice storm.

Ed read a letter from Stratford High School thanking Charleston Base on having the WWII SubVets at the event at the school.

**Old Business:** Marty Sessler gave an update on the new float trailer. Since the repairs are taking so long we are looking into using the current float after some repairs have been made. The float will only be towed in parades in the low country area.

Rick Wise restated the motion that had been tabled at the last meeting on supporting the efforts of the USS Clamagore Restoration and Maintenance Association, Inc. (CRAMA) to save the Clamagore. The motion was amended to read:

USSVI – Charleston Base supports the efforts of the USS Clamagore SS-343 Restoration and Maintenance Association, Inc. (CRAMA) to save the Clamagore.

A motion was made and seconded to accept the motion as amended. During the discussion base member Gary Williams pointed out that he believed that the Clamagore Veterans Association (CVA) had done nothing illegal and that their plan to use the money collected to place a memorial ashore near the position of the sunken Clamagore and the remainder as a scholarship fund for applicants related members was proper. Rick Wise pointed out that CRAMA was not asking for any money from Charleston Base or for Charleston Base approval of actions by the CRAMA Board of Directors. The motion was passed on a show of hands.

**New Business:** Base member Gary Williams made the following motion:

That USSVI-Charleston Base to reimburse the Base Chaplain at a rate of \$0.60 per mile for travel in the performance of his duties.

The motion was seconded and passed on a show of hands (27 yea – 24 nay).

**Good of the Order:** Rodney McKanna recommended that if any calendars were left they will be raffled off using the depth charge tickets at the end of the meeting.

**Depth Charge:** The depth charge was won by Jim Williams. Following that the calendars were raffled off.

Nick Nichols showed off a plaque made by base member Glenn Fleming. Information on Glenn's business is on the base meeting minutes page of the newsletter.

Charlie Hudson asked if any information was available about the Sub Ball. Ed is going to check with NNPS to see if we can get a special rate again.

Gary Williams announced he will bring a painting of a submarine on the surface to the March meeting to action off to support the Scholarship Fund.

**Meeting Adjourned:** Following the benediction by Base Chaplain Nick Nichols, the Base Commander adjourned the meeting at 2022.
