### **A Note From the Base Comptroller**

As we approach the end of the year we start collecting membership fees for 2020. These funds cannot be used in the 2019 budget so the only income left is the money from the Depth Charge drawings. This may mean that we will have a shortage at the end of the year. So what do we do?

We are currently at around 60% life members and 40% annual members. When we started Charleston Base Life Membership those fees went into what we call our investment fund so that when the majority of members were life members (as is the case now) that money could be used for Base operations. So it is my position that any shortfall at the end of the year will be covered by the investment fund.

At the last Board of Directors meeting a committee was established consisting of Base Treasurer Gordon Williams, Rick Wise and Carl Chinn to come up with guidelines for when the investment fund can be used.

Grayling was lost on September 9<sup>th</sup>, 1943, with the loss of all hands, 76 crew members near the Tablas Strait. Grayling was on her 8th war patrol and sank two ships before being lost.

Prior to submarine service he was on two DDG's, SMALLEY and FORREST ROYAL. Additionally he served at POMFPAC, POMFLANT and on HUNLEY, SIMON LAKE and HOLLAND and on Squadron 18 staff twice.
