Japanese submarine collides with commercial ship while surfacing in Pacific

Tokyo (CNN)A Japanese submarine collided with a commercial ship as it attempted to surface off the country's Pacific coast.

Three crew members from the Maritime Self-Defense Force submarine Soryu suffered minor injuries, and pictures from the Japanese Coast Guard showed it sustained damage to its fairwater planes, the wing like structures on its conning tower.

The accident occurred off the main island of Shikoku in southern Japan.

The Soryu, commissioned in 2009, is the first in its class of Japanese diesel electric-powered submarines. It displaces about 3,000 tons and has a crew of around 65.

The Defense Ministry said communications equipment on the sub was also damaged, although it was still able to operate.

"Soryu scraped the hull of the vessel as it was surfacing. It is extremely regrettable the MSDF submarine has collided with a commercial ship," Defense Minister Nobuo Kishi said.

The commercial vessel -- the Hong Kong-registered bulk carrier Ocean Artemis -- reported no damage, Coast Guard officials added.

Bradley Martin, a RAND Corp analyst and former US Navy captain who analyzed images of the damage, said the impact would have restricted the submarine's capabilities.

The incident comes almost 20 years to the day after a US nuclear-powered attack submarine accidentally hit and sank a Japanese fishing vessel, killing nine people -- including four high school students -- near Honolulu.

Use our telephone self-service option

If you are a retiree, don't use myPay and your mailing address on file with DFAS is current, you can get a copy of your 1099R through our telephone self-service option.

Please note that 1099-R reissues requested through the telephone self-service option cannot be mailed prior to February 10, 2021.

Use the quick and easy AskDFAS online option

If the address you have on file with DFAS is out of date and you are not a **myPay** user, you can get your 1099R sent to an updated address by [submitting your request online at AskDFAS](#). You can request your 1099R be sent either to your current address or to a new address using an online form. Plus, you can request prior year 1099Rs. You will receive your 1099R in the mail in seven to ten business days.

Please note that 1099-R reissues requested through AskDFAS cannot be mailed prior to February 10, 2021.

Getting a 1095-B

Please note: IRS Form 1095-B will only be available online via myPay, unless a request is received for a copy by mail.

As required by the Internal Revenue Service (IRS), DFAS continues to provide IRS Forms 1095-B or 1095-C via individual myPay accounts. These forms are created for military, retiree and federal civilian employees who receive healthcare insurance coverage through Tricare or Federal Employee Health Benefit programs. **According to the IRS, these forms are not required to prepare or file income tax returns** but will be available via myPay no later than Jan. 31, 2021.

Tax Levies and Debt Recoupments

Military retirees who owe federal taxes may be subject to a levy in order to pay an overdue tax bill. Military retirement payments are subject to the Federal Payment Levy Program through the Internal Revenue Service. Military retirement payments could be levied (reduced) by 15 percent through the Federal Payment Levy Program. The Federal Payment Levy Program only goes into effect if you have not paid your taxes on time or made arrangements to pay your overdue tax bill. Before a levy is issued, you will receive an initial tax bill with information on what you owe and how to pay it. You will also receive a final tax bill with information on what you owe, how to pay it, what can happen if you don't pay and an explanation of your appeal rights. The IRS will not issue a levy if you pay what you owe, or make payment arrangements, within 30 days after the final billing notice is sent. The federal tax levy could remain in place until the debt is satisfied.

In the case of garnishments, the collection action is mandatory and any rebuttal concerning the levy must be addressed to the IRS.

NOTE: Annuity payments are not subject to IRS tax levy collections.

COVID-19 VACCINATIONS AT N. CHARLESTON VA CLINIC

On Feb. 1, 2021 the Ralph H. Johnson VA Medical Center opened a portion of its new North Charleston VA Outpatient Clinic, located at 6450 Rivers Ave., to serve as a temporary COVID-19 vaccination clinic for Veterans.

Full clinic operations are scheduled to open summer 2021, but in the interim, the Charleston VA is making use of this space to efficiently and effectively vaccinate Veterans ages 70-years-old and older. Vaccinations are by appointment only, and eligible Veterans can make an appointment by calling 843-789-6900. You do not need to be in the VA system to get this vaccine.

AMBERJACK was lost on February 16, 1943 with the loss of 72 officers and men on her third war patrol. While off the coast of Babaul, she was attacked by a Japanese patrol plane, attacked by a torpedo boat and then depth charged by a subchaser. One additional man was killed earlier on the last patrol.

There are several shipmates and family members who have given me information which they wish to be kept confidential at this time.
