USS KETE (SS-369) 20 March 1945 – 2nd war patrol Lost with all hands – 87 souls

USS F-4 (SS-23) 25 March 1915 - foundered Lost with all hands – 21 souls

USS TULLIBEE (SS-284) 26 March 1944 – 4th war patrol Lost with 79 souls – 1 POW survived the war

USS TRIGGER (SS-237) 26 March 1945 – 12th war patrol Lost with all hands – 89 souls

Secretary – Gordon Long:

The Minutes from the February Base meeting had been published in the Base Newsletter and promulgated on the Base website. A Base member noted a date error in the Lost Boat section of the Minutes. The correction was made and resubmitted for publication on the Base website. There were no other additions, changes or deletions to the February Base meeting minutes and were approved with the correction.

Treasurer – Gordon Williams:

The Treasurer's Report for February has been published and promulgated on the website. Due to the turmoil in the markets, the Base Investment Fund lost \$2007 as of this meeting date. There were no additions or deletions. The report was approved as provided. Treasurer reported that Charleston Base donated \$250 to the Submarine Birthday Ball.

Chaplain – Nick Nichols:**Highlighted boat of the month:**

TULLIBEE was lost on March 26, 1944 with the loss of 79 officers and men, on her 4th war patrol. It's believed she was a victim of a circular run by one of her own torpedoes. The lookout was the only survivor and he survived the war as a Japanese prisoner. There are several shipmates and family members who have given me information which they wish to be kept confidential at this time.

MS1(SS) Stephen S. Morris departed on March 4, 2020 at his home. Steve would have been 75 in June. He joined the Navy in 1963 and left in 1967, reentered the Navy in 1979 and left in 1987. Steve was a Life Member of USSVI National (2009) and Charleston Base (2009). He qualified on USS STURGEON SSN-637 in 1983 and also served on JOHN C. CALHOUN SSBN-630. Prior to entering the submarine service he served on USS INVESTIGATOR AGR-9, USS FLOYD COUNTY LST-762 and USS KITTYHAWK CV-63 in addition to serving at USAMPHIBASE SAN DIEGO and CHARLESTON NAVAL BASE.

On Friday, March 6, Walt Deal and Gary Williams conducted a welfare check on Steve. He was not at breakfast on Wednesday morning and after calling him without an answer, they went to his house and found him deceased in his bedroom. The Coroner reported natural causes. There will be no service. Walt notified the family and found out that no one was planning to come into town so he and Margie took responsibility and paid for Steve's cremation. As GW said in his email, Walt took care of everything, and he took care of Walt and Margie.

For all the Base members who live alone, it is important to have something available with your Next-of-Kin information. This could be papers left visible for someone to see. It could be left in your smartphone outside of the screen lock as an emergency contact.

A.C. Mitchum, Walt Deal's brother-in-law, passed away March 8 at his home. He was in the Navy during the Korean War. The funeral was today at 1400.

Closing Ceremony

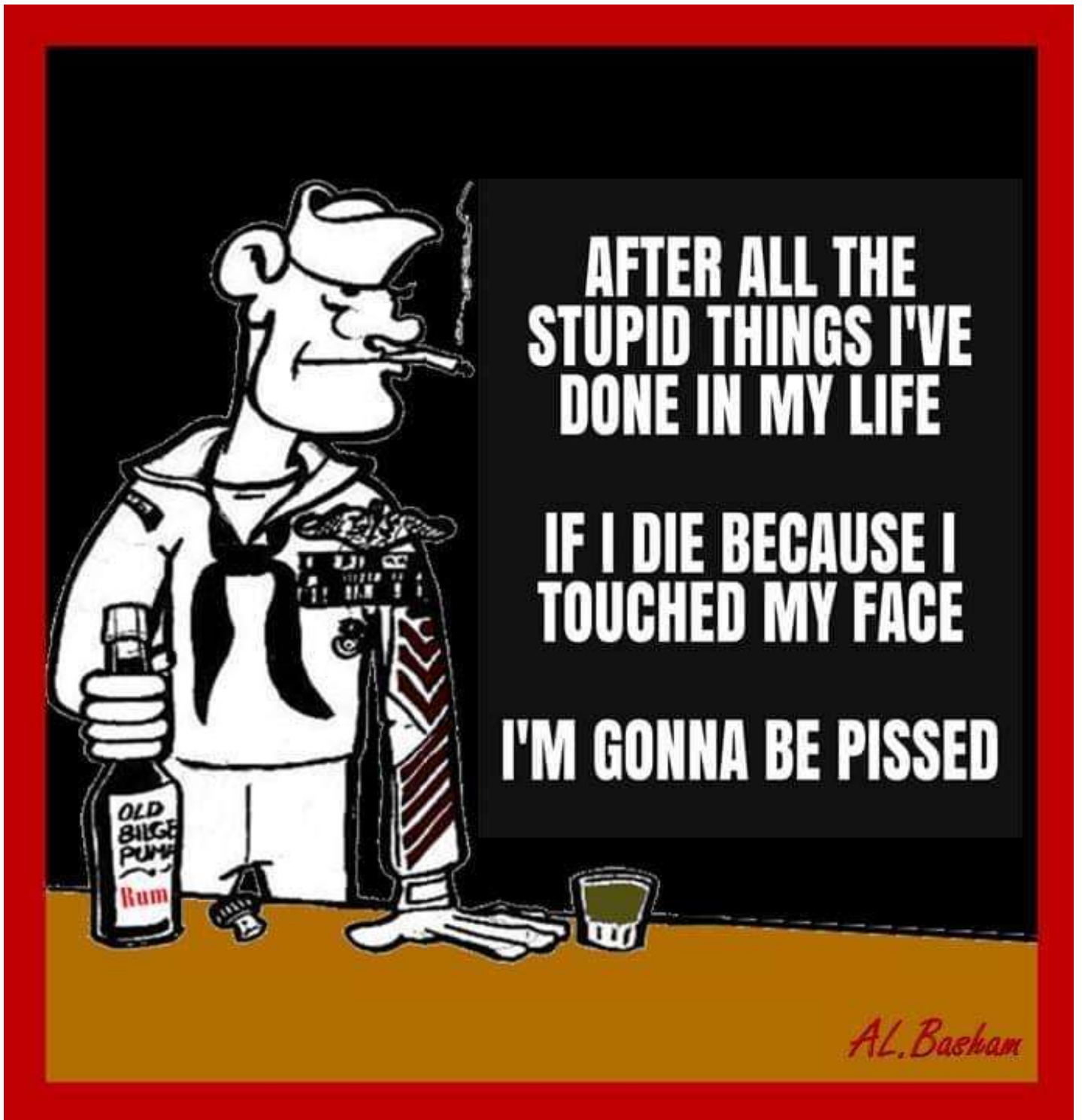
Chaplain Nick Nichols led the group in a prayer of Benediction.

HUMOR (and Boy! Do We Need it!)

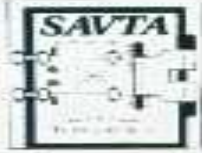
- Half of us are going to come out of this quarantine as amazing cooks. The other half will come out with a drinking problem.
